STATE REASONS & JUSTIFICATION FOR HISTORIC STRUCTURE OR HISTORIC SITE DESIGNATION

Tailor Henry Schuetter came to America from Prussia in 1870 and immediately found work in his trade in Appleton. By 1883 he became proprietor of his own tailoring business which became a leading establishment of its kind in Appleton and Northeastern Wisconsin. The <u>Commemorative Biographical Record of the Fox River Valley</u> described him as "one of the representative thorough businessmen and wide-awake citizens of the place."

The Queen Anne style Schuetter home, designed by local architect G.A. Tenbusch, was built in 1890 across from the Outagamie County Courthouse. The home is located in one of Appleton's original neighborhoods. Many leading citizens of Appleton at the time lived across the street to the south on Prospect Avenue. The home was added to the National and State Registers of Historic places on July 5, 1996 for its architectural significance. The following is a description of the house as written in the National Register nomination form:

"The 1890 Schuetter house exhibits the majority of the (Queen Anne) characteristics with its asymmetric front and side gables, two story bay and multiple dormers providing irregular plan and massing and wall projections, clapboard and fish scale siding, brick and sandstone adding surface texture

variety, steep roof, cutaway bay, wrap-around porch and round turret contributing Queen Anne detailing. The use of free classic porch columns, Federal style windows, a belt line of dentils, and cornice line modillions predict the coming of a Colonial Revival period to Wisconsin prevalent from 1895-1920. The homes use of beveled glass, tracery, colored glass, leaded glass, wooden sunburst, crown ornamentation over windows, interior wainscoting, pocket doors, oak newel post and balustrades and basic floor plan are details that reflect aesthetic and lifestyle qualities important to Victorian America. Though not the largest or the grandest of the Queen Annes in Appleton, the Schuetter house remains a significant local representation of a middle class Queen Anne style home."






