## **CHRISTMAS TREE VENDOR LICENSE INFORMATION**

- Christmas Tree Vendor Licenses are required within the City of Appleton where individuals are to engage in the business of selling Christmas trees. See City of Appleton Municipal code Sec. 9-566 for more information and definitions.
  - The sale of Christmas Trees may require additional permits and licensing through the City of Appleton Community Department.
  - Outdoor Christmas tree sales lot may be allowed on a lot for no more than forty-five (45) total days per calendar year. See City of Appleton Municipal code Sec. 23-54 for more information on temporary uses and structures.
- Christmas Tree Vendor Licenses are valid for one calendar year from January 1<sup>st</sup> December 31<sup>st</sup>.
- Once a completed Christmas Tree Vendor License application is returned to the Office of the City Clerk it is reviewed by several City Departments for approval. This process takes approximately 5 business days, so please plan accordingly.
- To apply for a Christmas Tree Vendor License, return the completed, signed application form to the Office of the City Clerk.
- Individual Christmas Tree Vendor Licenses are required for <u>each location</u> where Christmas Trees will be sold.
- License fees are non-refundable and are to be paid at the time of filing the application form. Fees are as follows:
  - Christmas Tree Vendor License \$45.00
