PETSTORE/KENNEL LICENSE INFORMATION

- Per the City of Appleton Municipal code, a Pet Store is defined as any retail establishment in a commercially zoned building whose business includes the sale of live animals. A Kennel is defined as any premises wherein any person is engaged in the business of boarding, breeding, buying, letting for hire, training for a fee, or selling of dogs or cats. See City of Appleton Municipal Code Sec. 3-1 for more definitions.
- Pet Store/Kennel Licenses are valid for a period of one year from July 1st June 30th.
- To apply for a Pet Store/Kennel License, file your completed, signed application form with the City Clerk's office.
- Once a completed Pet Sstore/Kennel License application is returned to the Office of the City Clerk, it is reviewed by several City Departments, the Safety and Licensing Committee and the Common Council for approval. This process takes approximately 4 weeks, so please plan accordingly.
- License fees are non-refundable and are to be paid at the time of filing the application form. Fees are as follows:
 - o **Pet Store** -\$97.00 initial

\$82.00 renewal

Kennel - 10 or less animals: \$62.00

11 to 25 animals: \$137.00 26 to 50 animals: \$262.00

More than 50 animals - \$5.00 per animal with a minimum fee of \$287.00
