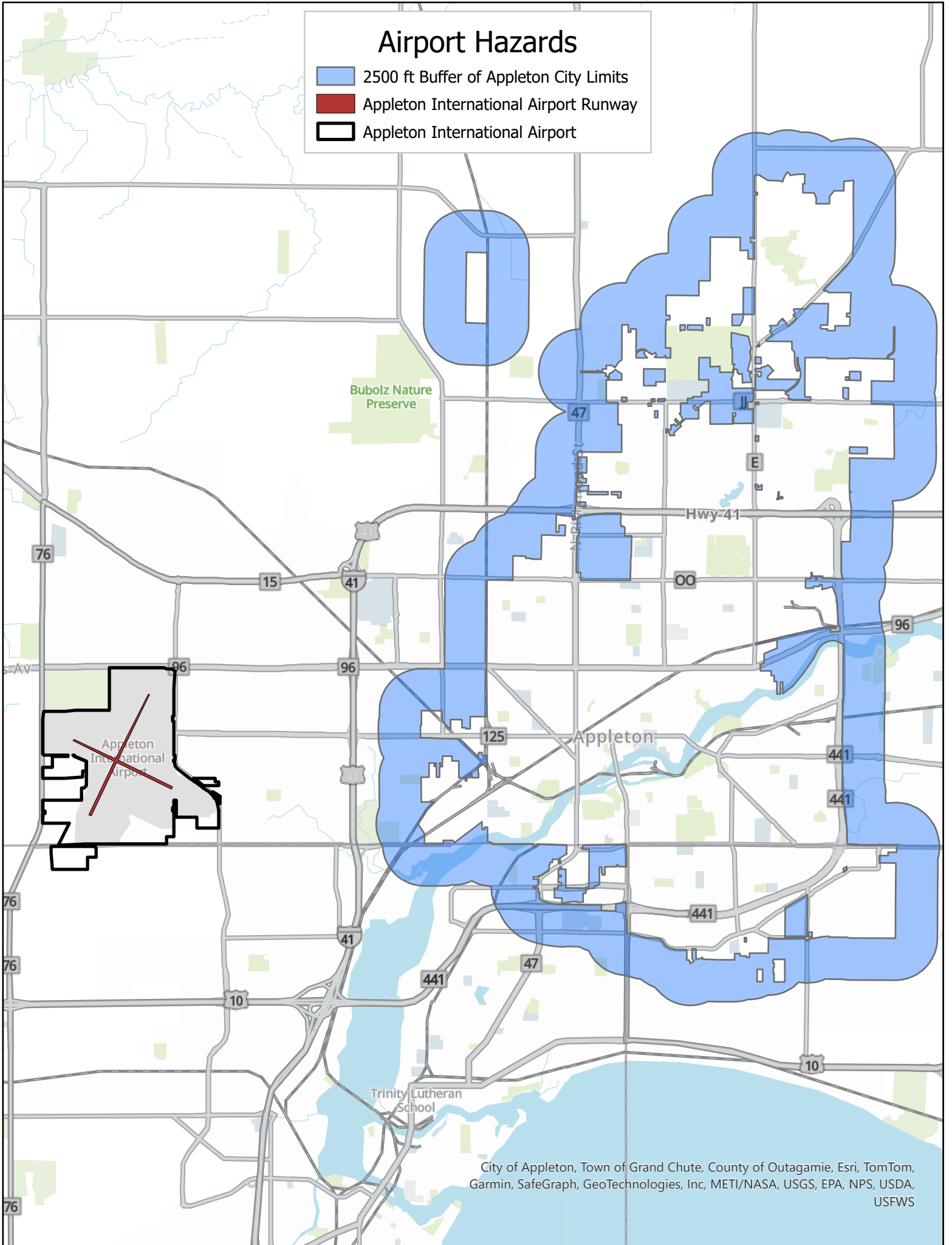

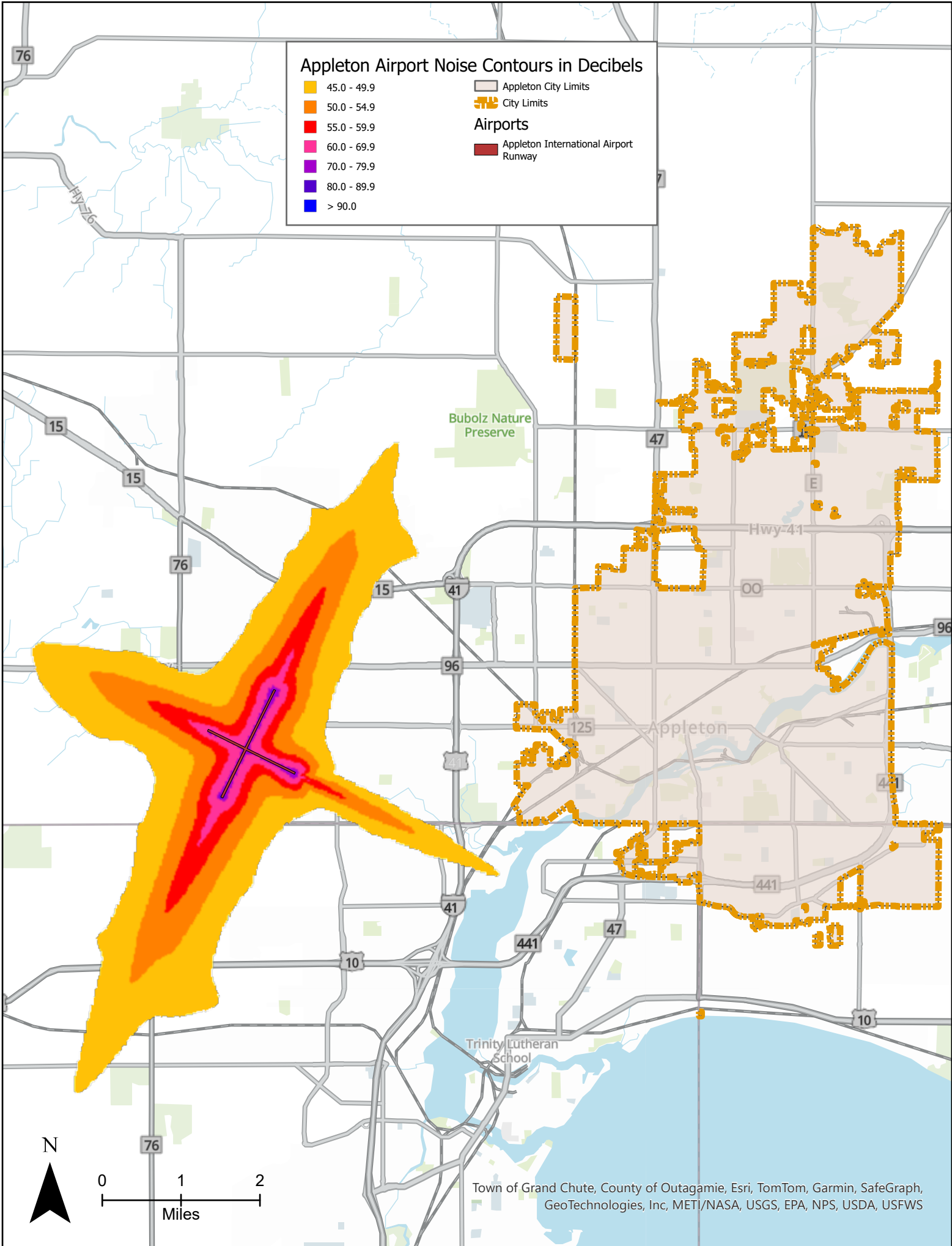

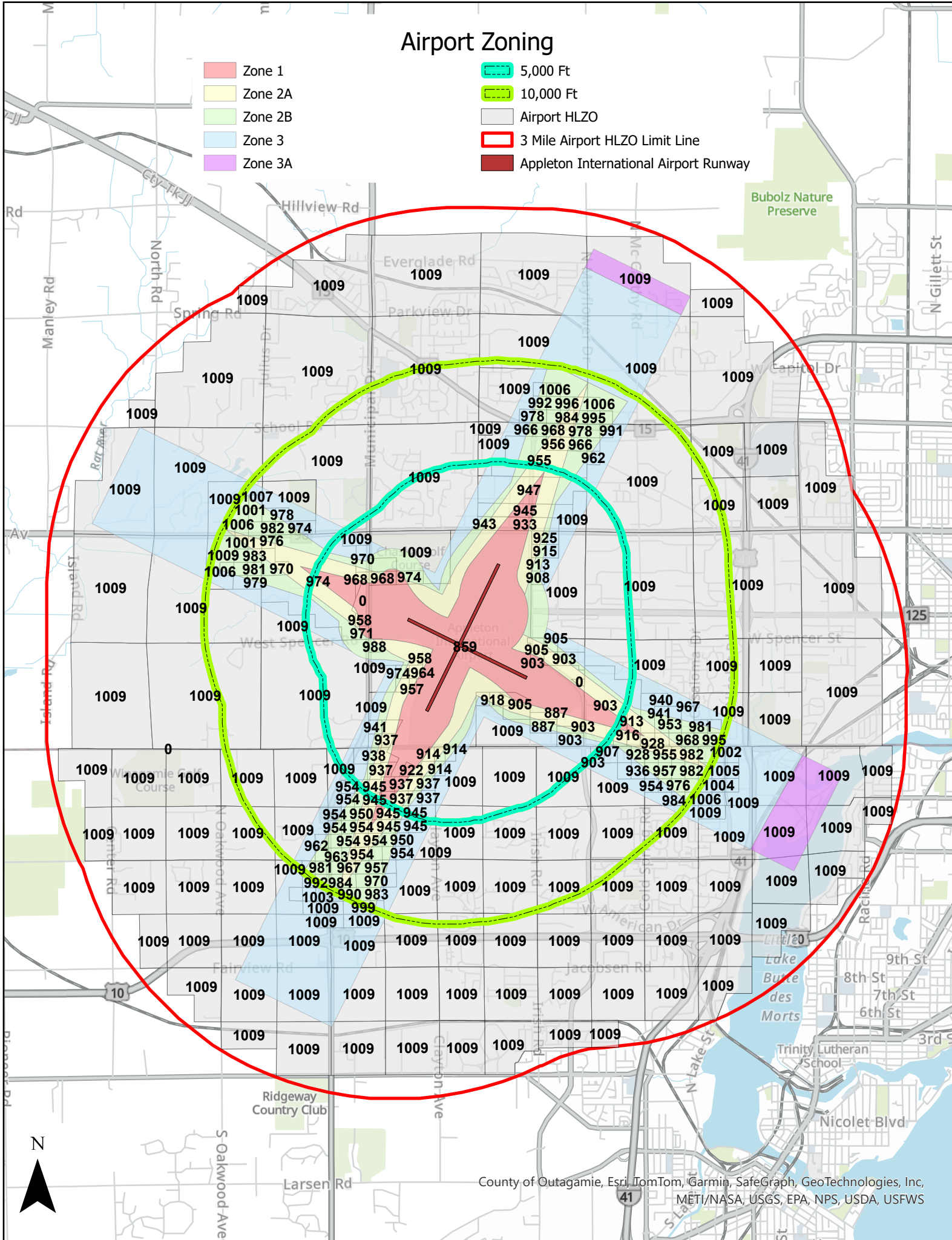
Appleton Airport Noise Contours in Decibels

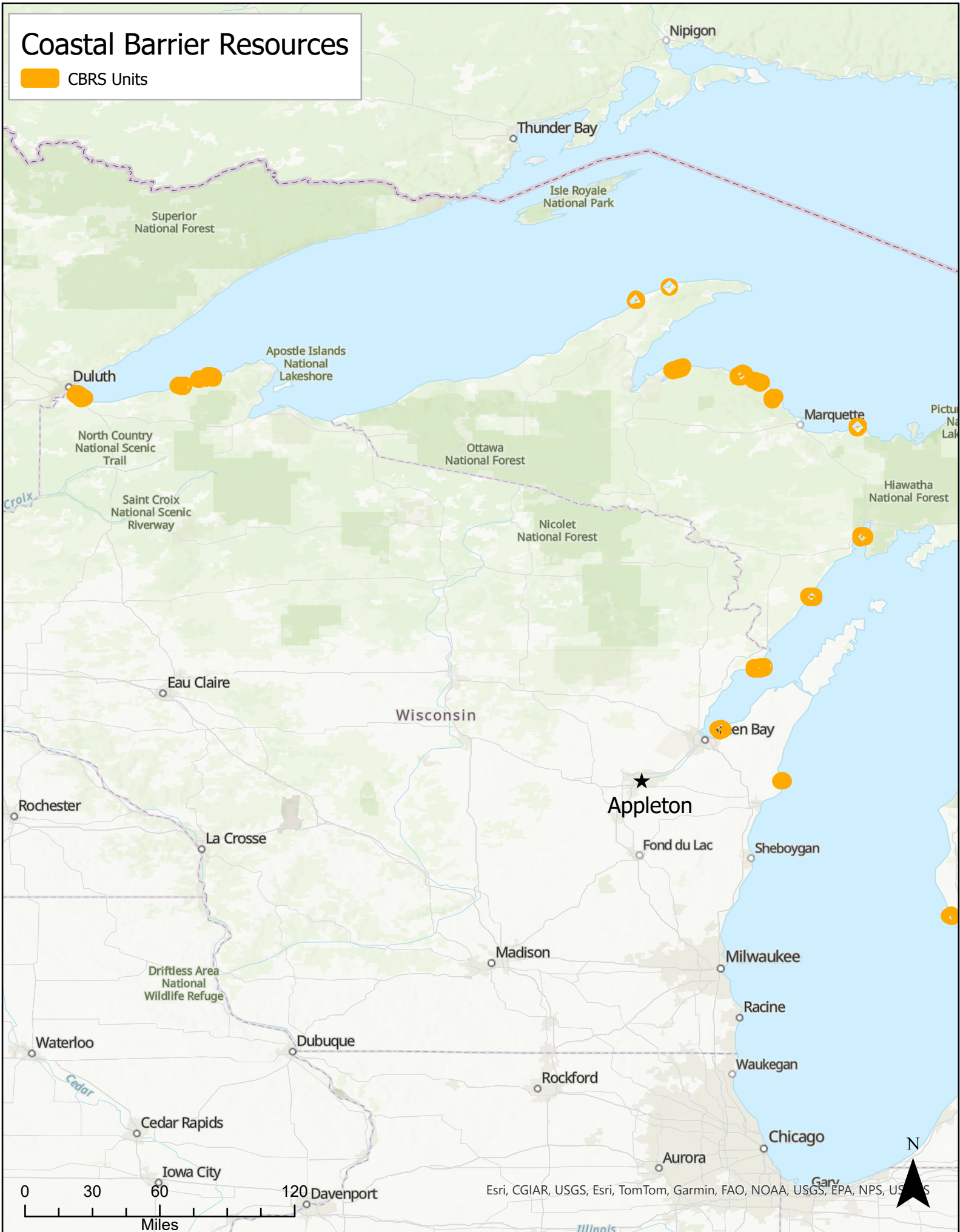

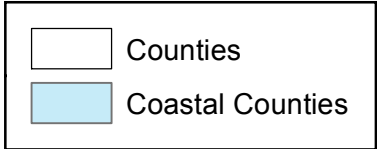


Coastal Zone Management Coastal Counties in Wisconsin

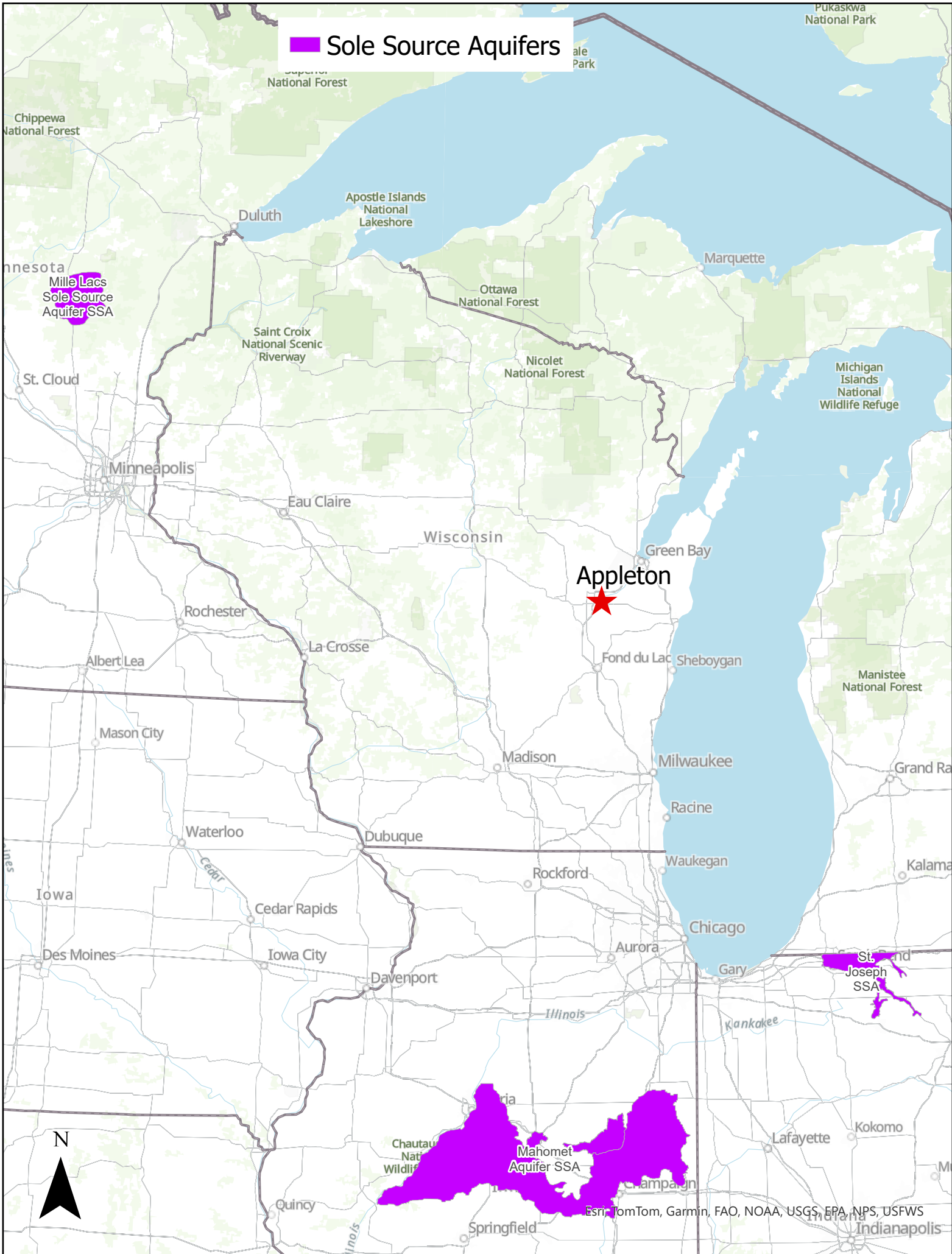

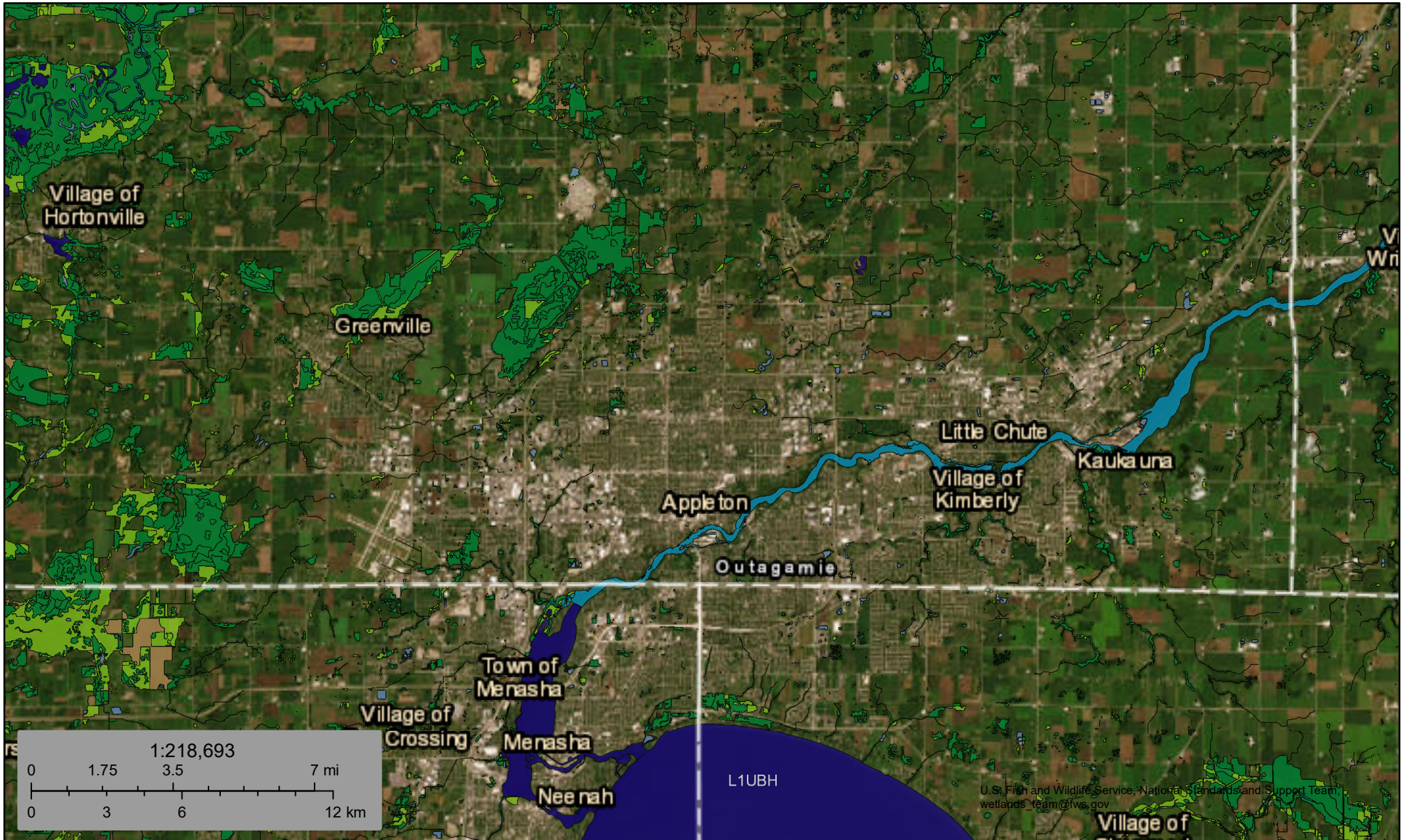


Wisconsin's Coastal Counties
