- Mobile Home Park Licenses are required with the City of Appleton for individuals who intend to maintain and or manage a manufactured and mobile home community. See City of Appleton Municipal code Sec. 11-46 for more information and definitions.
- Mobile Home Park Licenses are valid for one year, beginning on July 1st and ending June 30th.
- Once a completed Mobile Home Park License application is returned to the Office of the City Clerk
 it is reviewed by several City Departments. The application is also reviewed by the Safety and
 Licensing Committee and the Common Council for approval. This process takes approximately 3
 weeks, so please plan accordingly.
- To apply for a Mobile Home Park License, return the completed, signed application form to the Office of the City Clerk.
- License fees are non-refundable and are to be paid at the time of filing the application form. Fees are as follows:
 - o Mobile Home Park License \$132.00
